 inappropriate links or statements by any consultancy organization stating or implying that certification
 would be simpler, easier, faster, or less expensive if AGAH AFARIN ARIA were to be elected for
 certification. AGAH AFARIN ARIA does not state nor implies that certification would be simpler, easier,
 faster, or less expensive if a specified consultancy organization were used
- In order to ensure that there is no conflict of interests, personnel who have provided management system consultancy, including those acting in a managerial capacity, are not employed by AGAH AFARIN ARIA to take part in an audit or other certification activities if they have been involved in management system consultancy towards the client. A recognized mitigation of this threat is that personnel shall not be enrolled for a minimum of two years following the end of the consultancy.
